## *BTCS iPad Agreement*

The following policies refer to the use of an Apple iPad to be used as a digital learning tool. Students are also required to follow all the guidelines outlined in the Blessed Trinity Catholic School's Responsible Use Policy. As Blessed Trinity Catholic School's Digital Initiative centers on new technologies and educational methodologies, additional policies will continually be reviewed and this set of policies updated.

BTCS retains sole right of possession of the iPad and related equipment. The iPad will be issued to students according to the guidelines set forth in this document. The classroom teacher, school administration, or school employee retains the right to collect and/or inspect the iPad at any time and to alter, add or delete installed software or hardware. Usage is a privilege and not a right.

### **1. Cost of the iPad**

- A. The cost of the iPad includes: the iPad, case, charger, and software applications (apps). All should be returned in good working condition at the end of the school year, when a student withdraws, or terminates enrollment at BTCS for any reason.
- B. Apps will be installed on the iPads and will be the property of the student. Certain apps may be included on the iPad as part of a classroom instruction and will remain under the ownership of BTCS.

### **2. Damaged, Lost or Stolen iPads**

- A. The student's iPad has limited liability coverage. Should parents be required to pay for damage or replacement, payments will be made to the BTCS.
- B. Blessed Trinity Catholic School's coverage includes:
  1. Replaced screen – replacement cost (First Two Times \$50, 3<sup>rd</sup> time is Replacement Cost determined by Apple at time of need)
  2. Replacement of cases or chargers – replacement cost (\$40-\$60)
  3. All other results of damage - \$150 deductible for each occurrence
  4. Lost or stolen iPad – replacement cost (up to \$499)
- C. Should an iPad be damaged, lost, or stolen the student and parent/guardian should immediately notify the school administration. A police report will be filed for any lost or stolen devices.
- D. In the event of a lost or stolen iPad and once a police report is filed, BTCS, in conjunction and only in conjunction with police, may deploy location software which may aid the police in recovering the iPad.

### **3. Student use of the iPad**

- A. iPads will be distributed in the event of long-term school closure and collected when school reopens. All iPads must be returned or the student may be charged replacement costs of the iPad.
- B. Each iPad will be distributed with a school-issued case, which must always remain on the iPad. Students may replace the case if approved by school administration. In such instances, the school-issued case must be returned to the Tech Department.
- C. The iPad is the property of BTCS and as a result may be seized and reviewed at any time. The student should have NO expectation of privacy of materials found on an iPad or a school supplied or supported email service. Devices may be selected at random and subject to inspection.
- D. The iPad comes equipped with both a front and rear-facing camera and video capacities. Students must ask permission before recording an individual or group. BTCS retains the rights concerning any recording and/or

publishing of any student or staff member's work or image. Students must obtain permission from an administrator to publish a photograph or video of any school related activity.

- E. While personalized screensavers or backgrounds may be permitted, inappropriate or provocative images including but not limited to pornographic images, guns, weapons, inappropriate language, threatening language, drug, alcohol, or gang related images are not permitted and subject to disciplinary action.
- F. Students may have the ability download appropriate music to the iPad. This will be a privilege, not a right and may be subject to removal.
- G. The iPad affords limited electronic storage space. As with all electronic files, it is good practice to back up, duplicate, or archive files to an independent storage space.
- H. All students should recognize and guard their personal and private information. While on the Internet, students shall not reveal personal information, including a home address or phone number, or the address or phone numbers of other students.
- I. BTCS makes no guarantee, written or implied, that materials on the iPad, including student work, will be safe from deletion or corruption, accidental or otherwise.

### **4. Student Responsibility**

- Use the iPad as a learning tool while creating original work that is not plagiarized or borrowed from a classmate or any other individual or source.
- Assume personal responsibility for the iPad and take care to avoid damage and/or loss of the device.
- Participate in online activities and follow directives of BT staff in regards to appropriate use of the iPad.
- Use online resources safely, respectfully, and appropriately

### **5. Parent Responsibility**

- Be informed of your child's activities on the iPad, periodically use the device to become familiar with its capabilities.
- Communicate concerns with teachers regarding the implementation and use of technology.
- Communicate with your child regarding their use
- Talk to your child about values and standards that your child should follow on the use of the online resources just as you would on the use of all media information sources such as television, telephones, movies, and radio.

### **6. School Responsibilities**

- Provide access to Internet, email and other online educational resources.
- Provide Internet filter to attempt to block inappropriate material.
- Provide guidance to aid students in using the iPad as a learning tool and help assure student compliance of the RUP.
- Use iPad effectively as a vital tool in the instruction and learning process.

7. Students and parents agree that BTCS personnel may search the school issued iPad, and at no time, should a student expect a right to privacy of materials on the iPad.	
8. Students and parents leaving BTCS must return the iPad and accessories in good working condition.
